- 1) **Spaces** - All are 10' x 10'. The sharing of booths is not permitted. Crafters must provide their own tables, chairs, display shelves & protection from inclement weather. No electricity provided. Your booth must be always staffed. Low decibel generators are allowed but there is no electrical hook up available.
- 2) **Space Assignment** - Assigned on a first come, first served basis using the date the contract and payment are received. Your space will not be guaranteed until all paperwork (registration form & tax form ST 19) is submitted, and payment is received.
- 3) **Crafter Set Up & Take Down** - Check in will be on Saturday, July 20, 2024, at entrance of VFW parking lot on Monroe Street, Garrison, MN. Booth set-up will be communicated under a separate email assigning times and location. All Crafter vehicles must be moved to the designated area prior to 9:00 am. Take down at 6:30 pm on Saturday, July 22, 2023. Crafters are required to clean up & remove all debris from their space area before leaving.
- 4) **Craft items** - Only one independent sales consultant of each brand (i.e., Norwex, Thirty One, Mary Kay, etc.) All merchandise must be respectful.
- 5) **Proceeds** - All sales go to the crafter. Tax rate in Garrison 8.38%.
- 6) **Liability & Insurance** - The Garrison Commercial Club is not liable for any damages or injury to persons or property, sustained by conditions or activities on the premises. Crafter is solely responsible for protecting their property and merchandise from damage or loss.
- 7) **Refund Policy** - No refunds. Space cannot be transferred to another crafter. If the event is cancelled, the Garrison Commercial Club agrees to refund all money paid by the crafter within 30 days of event cancellation.
